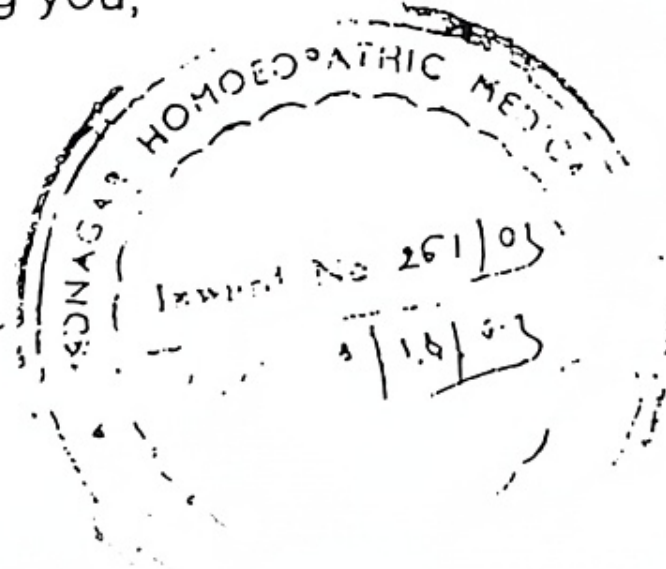

**Sub: Application for letter of permission for functioning of Ahmednagar Homoeopathic Medical College, Savadi Road, Ahmednagar, Maharashtra - 414003 for continuing BHMS course with intake capacity of 100 seats for the academic year 2025-26- regd.**

Sir,

Ahmednagar Homoeopathic Medical College, Savadi Road, Ahmednagar, is functional since 1989 has applied for permission for sanction of 100 seats for BHMS for the academic year 2025-26. The College was inspected on 27.02.2025 & 28.02.2025 in which the entire functional profile has been examined. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

## **1. Teaching faculty.**

- A. In light of the relaxation order issued by MARBH on 16.04.2025 following teacher shall be appointed as early as possible :-
- 01 Assistant professor in department of anatomy.
  - 01 Assistant professor in department of Community of Medicine.
  - 01 Assistant professor in department of Repertory.
- B.
- A separate visiting faculty of minimum cadre of Assistant Professor should be engaged for teaching fundamentals of psychology.
  - Details of practicing consultants as visiting faculty of modern medicine or homeopathy are not available.

## **2. Miscellaneous**

- NABH accreditation or registration on portal for hospital not done.
- NABL accreditation not done.
- Salary of teaching staff and non-teaching staff is not as per MES 2024.

Considering the above observations observed inspection MARBH has decided to give **Conditional Permission to Ahmednagar Homoeopathic Medical College, Savadi Road, Ahmednagar, Maharashtra- 414003 for continuing BHMS course with intake capacity of 100 seats for the academic year 2025-26.**


It is further to mention that all admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as All India Quota. Counselling for seats under all India quota shall be conducted by respective Counselling Authority of State/UT govt as designated by Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

**All deficiencies mentioned at point 1(B) and 2 shall be rectified within a period of one month and the compliance report shall be submitted for verification, failing which permission for academic year 2025-26 may be withdrawn.**
